

**ASSESSOR QUALIFICATIONS/REQUIREMENTS**

<p><b>Definition of Assessor roles:</b></p> <p>Team member Sole Lead</p>	<p>Assessor who participates as a member of an assessment team. Assessor who performs assessments as the sole representative of the AABB. Assessor who is the leader of a team of assessors.</p>
<p><b>Responsibilities</b></p>	<p><b>All assessors:</b></p> <ul style="list-style-type: none"> <li>• Abide by time frames set by the accreditation program</li> <li>• Use pre-assessment materials to prepare for assessment</li> <li>• Perform assessment</li> </ul> <p><b>Lead/sole assessor:</b></p> <ul style="list-style-type: none"> <li>• Serves as the contact person to the facility, if applicable</li> <li>• Prepares the summary report that is left at the facility</li> <li>• Submits the assessment report to National Office</li> </ul> <p>In addition, the lead assessor:</p> <ul style="list-style-type: none"> <li>• Communicates with team members</li> <li>• Serves as the spokesperson for the team</li> <li>• Coordinates the assessment</li> </ul> <p><b>Trainee</b></p> <ul style="list-style-type: none"> <li>• Observe experienced assessors as they perform all aspects of the assessment</li> <li>• Assist experienced assessors by applying the information obtained from new assessor training workshops to assessment process (trainees are not to work independently)</li> <li>• Work with experienced assessors to complete training checklist and evaluation</li> <li>• Observe the preparation of the summary report</li> </ul>
<p><b>Education</b></p>	<p><b>Donor, Transfusion Assessors</b> - Bachelors degree or equivalent in a related science</p> <p><b>Cell Therapy Assessors</b> (HPC, Cord Blood, Somatic Cell) - Bachelors degree in a biological science</p> <p><b>Relationship Testing Assessors</b> - advanced degree (e.g. PhD or MD) or BA/BS degree in biological science, with experience</p> <p><b>Perioperative Assessors</b> - minimum 2 year degree in related science</p> <p><b>Immunohematology Reference Laboratory Assessors</b></p> <ul style="list-style-type: none"> <li>- Bachelors degree or equivalent</li> <li>- must meet the requirements of a “supervisor” as defined in the current edition of Standards for Immunohematology Reference Laboratories</li> </ul> <p><b>Molecular Testing Laboratory Assessors</b></p> <ul style="list-style-type: none"> <li>- Bachelors degree or equivalent</li> <li>- Must meet the requirements of a “laboratory supervisor” as defined in the current edition of Standards for Molecular Testing for Red Cell, Platelet, and Neutrophil Antigens</li> </ul>

<p><b>Technical Training and Experience</b></p> <p><i>Note: Direct work experience = actual experience performing technical duties</i></p>	<ul style="list-style-type: none"> <li>• <b><u>Donor Center, Transfusion Service, and Relationship Testing Assessors</u></b> <ul style="list-style-type: none"> <li>- Minimum <b>3 years</b> direct (hands on) work experience, a portion of which has occurred in the last 3 years.</li> </ul> <p style="text-align: center;"><b>AND</b></p> <ul style="list-style-type: none"> <li>- Minimum 3 years direct work experience &gt; 3 years in the past AND current active involvement in a related field that allows an individual to keep informed of scientific, technical, and accrediting requirements of the activity. (considered when applicant has had direct work experience in the past and now works in a capacity such as supervisor of operations or quality assurance)</li> </ul> </li> <li>• <b><u>Immunoematology Reference Laboratory Assessors</u></b> <ul style="list-style-type: none"> <li>- Minimum <b>3 years</b> direct work experience in an immunoematology reference laboratory (a portion of which has occurred in the last 3 years).</li> </ul> <p style="text-align: center;"><b>OR</b></p> <ul style="list-style-type: none"> <li>- Active involvement in a related field that allows individual to keep informed of scientific, technical, and accrediting requirements of the activity (requires review and approval of IRL-APU).</li> </ul> </li> <li>• <b><u>Perioperative Assessors</u></b> <ul style="list-style-type: none"> <li>- Minimum <b>3 years</b> direct work experience (a portion of which has occurred in the last 3 years).</li> </ul> </li> <li>• <b><u>Cellular Therapy Assessors</u></b> (HPC, Cord Blood) refer to the table for required cumulative laboratory experience, directly related to HPC or Cord Blood activities, which has occurred in the last 4 years</li> </ul> <table border="1" data-bbox="383 1094 1500 1379" style="width: 100%; text-align: center;"> <thead> <tr> <th style="width: 33%;">Direct work experience # procedures /YR</th> <th style="width: 33%;">Bachelor’s Technologist (Yrs.)</th> <th style="width: 33%;">Doctoral Degree (ex. 	<ul style="list-style-type: none"> <li>• <b><u>All Assessors:</u></b> <ul style="list-style-type: none"> <li>➤ Understanding of quality programs, assessments, or other quality practices either through actual experience or training;</li> <li style="text-align: center;"><b>and</b></li> <li>➤ Active participation (through either a managerial or technical position) in managing a quality program, performing assessments, or having responsibilities for quality control, process control or other quality-related practices that include cGMP related functions.</li> <li style="text-align: center;"><b>and</b></li> <li>➤ Successful completion of AABB Accreditation Program's New Assessor Training.</li> <li style="text-align: center;"><b>and</b></li> <li>➤ Successful completion of assigned trainee assessment by accompanying an approved assessor to assess a facility.</li> </ul> </li> </ul>
<b>Commitment</b>	<ul style="list-style-type: none"> <li>• Participate in at least 2 facility assessments per year, when requested</li> <li>• Participate in Assessor Continuing Education Program</li> <li>• Abide by Code of Conduct</li> <li>• Abide by Confidentiality Agreement</li> <li>➤ Please note that some assessments may last more than 1 day and may involve travel outside of your local area.</li> </ul>
<b>Attributes/Abilities</b>	<ul style="list-style-type: none"> <li>• Knowledgeable in assessed activities</li> <li>• Good verbal/written communication skills</li> <li>• Objective (use only facts)</li> <li>• Professional (fair, report exactly what is found)</li> <li>• Punctual</li> <li>• Positive (judge on basis of effectiveness of a quality system; consider nonconformances as an opportunity for improvement)</li> <li>• Practical (assessment beneficial to facility being assessed)</li> <li>• Prepared</li> </ul> <p>When performing as a lead or sole assessor:</p> <ul style="list-style-type: none"> <li>• Demonstrate facilitation skills</li> <li>• Demonstrate organizational skills to accomplish group activities</li> </ul>
<b>Continuing Education</b>	<p>Must successfully recertify as an assessor by participating in the Assessor Continuing Education Program.</p>
<b>Competence Requirements</b>	<p>Competence will be assessed by input from the following:</p> <ul style="list-style-type: none"> <li>• Facility feedback on assessment (Post-Assessment Questionnaire)</li> <li>• Validation assessment conducted by AABB</li> <li>• CMS validation results if performed within 60 days of AABB assessment (when available)</li> <li>• Lead/Sole Assessor's Report</li> <li>• Team Assessor's Report</li> <li>• Adherence to timeframes, completeness/clarity of assessment reports</li> </ul> <p>Assessors will be evaluated on the following attributes:</p> <ul style="list-style-type: none"> <li>➤ Represents the AABB with Integrity</li> </ul>

	<ul style="list-style-type: none"><li>➤ Manages facility information in a confidential manner</li><li>➤ Communicates effectively with team and facility</li><li>➤ Demonstrates knowledge of AABB standards</li><li>➤ Relates observations to specific standards</li><li>➤ Synthesizes information by asking open ended questions</li><li>➤ Applies systems analysis to the assessment process</li></ul> <p>In addition to evaluation from assessment feedback, competence will also include biennial submission of continuing education and attendance at annual meeting assessor day (or AABB Live Learning Center review).</p>
