Additional fees may apply if activities are performed at multiple sites.
Travel fees are billed for non-US locations (excluding Canada) at \$1,568 per year.
American Rare Blood Donor Program (ARDP) annual fee is \$1,150 per year. This fee does not include blood unit charges.
