\*Annual Volume Fee is assessed for:

Donor centers and transfusion services on the total number of units collected or transfused (whichever is greater) per year.

Donor testing laboratories on the number of samples tested per year.

Cellular therapy institutions (HPC, Clinical, Cord Blood, Somatic) on the total number of units collected, processed or transplanted (whichever is greater) per year.

Perioperative institutions on the total number processed per year.

IRL and molecular testing institutions on the number of samples per year.

<sup>†</sup> Relationship testing activity accreditation requires dedicated lead assessor resources. Any institution that has two accreditation activities that require a lead assessor activity that includes relationship testing, will incur two accreditation fees (lead assessor).

CLIA fees will be applied for each non-waived CLIA number.

Additional fees may apply if activities are performed at multiple sites.

Travel fees will be billed separately for non-US locations (excluding Canada)
