

Centers for Medicare & Medicaid Services Proposed Medicare Hospital Outpatient Payment Rates and Policies for CY 2023

On Friday, July 15th, the Centers for Medicare & Medicaid Services (CMS) released a proposed rule updating Medicare payment rates and policies under the hospital outpatient prospective payment system (OPPS) and the ambulatory surgical center payment system for calendar year (CY) 2023. CMS proposes to increase all payment rates under the OPPS hospital outpatient department fee schedule by 2.7 percent, which is based on the proposed hospital inpatient market basket increase in the hospital inpatient prospective payment system (IPPS). Significant proposals for the transfusion medicine and cellular therapy community include an increase for hospital outpatient payment rates for blood and blood products. **Comments are due to CMS on September 13, 2022.**

Proposed Payment Policies and Rates for Transfusion Medicine and Cellular Therapies

Consistent with the longstanding methodology used since 2005, CMS proposes to continue establishing separate payment rates for blood and blood products using a blood-specific cost-to-charge ratio (CCR) methodology, which uses actual or simulated CCRs from the most recently available hospital cost reports to convert hospital charges for blood and blood products to costs. CMS proposes to continue applying the blood-specific CCR methodology when calculating the costs of blood and blood products that appear on claims with services assigned to comprehensive ambulatory payment classifications (C-APCs). A C-APC is "a classification for the provision of a primary service and all adjunctive services provided to support the delivery of the primary service." Since the costs of blood and blood products are reflected in the overall costs of the C-APCs and the proposed payment rates of the C-APCs, CMS is proposing not to make separate payments for blood and blood products when they appear on the same claims as services assigned to the C-APCs.

CMS proposes to slightly increase payment rates for most blood products. As a result of the COVID–19 public health emergency (PHE) and concerns around incomplete claims data for CY 2020, CMS is proposing to use the CY 2021 claims data with CY 2019 (prior to PHE) cost report data for CY 2023 OPPS rate setting. In January 2022, AABB, ABC, and the American Red Cross submitted comments to CMS requesting the creation of new codes for COVID-19 convalescent plasma (CCP) administered in the outpatient setting based on the revised Emergency Use Authorization for CCP issued by the Food and Drug Administration (FDA) in December. As a result, CMS created HCPCS code C9507 for CCP used in the outpatient setting at a proposed rate of \$743.89, effective on or after December 28, 2021. Please see Tables 1 and 2 for a summary of the proposed payment rates for blood and blood products and transfusion, apheresis, and stem cell procedures.

As summarized in Table 3, CMS proposes to increase the payment rates for most of the transfusion and laboratory services covered by the OPPS. However, the proposed payment rate for 86999 (transfusion procedure) did slightly decrease to a proposed rate of \$14.00. Please see Table 3 for a summary of the proposed payment rates for transfusion laboratory services.



Table 4 summarizes the proposed payment rates for CAR T-cell therapies. The chimeric antigen receptor (CAR) T-cell therapy HCPCS code Q2041 (Axicabtagene ciloleucel car+) did not have a proposed payment rate for CY2023 as this code will be discontinued at the end of 2022. Therefore, the current payment rate of \$395,380.00 is effective until the end of the year. HCPCS Q codes are temporary codes CMS establishes to represent services and supplies that do not yet have a permanent code. AABB believes that the manufacturer will be working with CMS on submitting a HCPCS application for a permanent code.
