

Centers for Medicare & Medicaid Services CY 2024 Medicare Hospital Outpatient Prospective Payment System (OPPS) Final Rule Summary

On November 2, the Centers for Medicare & Medicaid Services (CMS) released a <u>final</u> <u>rule</u> updating Medicare payment rates and policies under the hospital outpatient prospective payment system (OPPS) and the ambulatory surgical center payment system for calendar year (CY) 2024. The final rule updates payment policies and rates for CY 2024. **The final rule is effective on January 1, 2024**.

Payment Policies and Rates for Transfusion Medicine and Cellular Therapies

Consistent with the longstanding methodology used since 2005, CMS finalized the proposal to continue establishing separate payment rates for blood and blood products using their blood-specific cost-to-charge ratio (CCR) methodology, which uses actual or simulated CCRs from the most recently available hospital cost reports to convert hospital charges for blood and blood products to costs.

For CY 2024, CMS finalized the proposal to use CY 2022 claims and cost report data to calculate payment rates. As detailed in the Tables below, CMS finalized CY 2024 payment rates and policies for all items and services furnished under OPPS, including blood products, transfusion, apheresis, stem cell procedures, and transfusion laboratory services. Decreases in payment rates were seen in blood and blood products (Table 1) and in Table 3 for HCPCS codes 86930 (frozen blood prep), 86931 (frozen blood thaw), and 86917 (red blood cell incubation with enzymes). Increases in payment rates for transfusion, apheresis, stem cell procedures, and Table 2 and Table 4.

Chimeric Antigen Receptor T-cell (CAR-T) Therapy Crosswalk Mapping

In the proposed rule, CMS noted that there were recommendations made by commenters in CY 2023 for CMS to revise the OPPS revenue code-to-cost center crosswalk to provide consistency with the National Uniform Billing Committee (NUBC) definitions and to improve the accuracy of cost data for ratesetting for CAR T-cell administration services. CMS analyzed the impact of the recommendation and determined that the revisions would more accurately account for CAR T-cell costs, specifically with CAR-T-related revenue codes that were not previously assigned cost centers. Thus, for CY 2024, CMS finalized their proposal to adopt revisions to the impacted revenue codes and the code-to-cost center crosswalk.

Request for Public Comment: Potential Payments for Establishing and Maintaining Access to Essential Medicines

CMS received many comments on their request for comment on their proposal to establish a separate payment to hospitals for maintaining access to a "buffer stock" of essential medicines under the Inpatient Prospective Payment System (IPPS). AABB, America's Blood Centers and the American Red Cross also submitted <u>comments</u> asking the agency to (1) include blood and blood products, and (2) ensure that the payments are sufficient to cover all costs associated with procuring and maintaining essential medicines, including a "buffer stock" of



blood and blood products. Based on the feedback received, CMS stated that a multifaceted approach to address pharmaceutical shortages and emergency preparedness is needed. Therefore, CMS will propose new Conditions of Participation and rulemaking to address hospital processes for a pharmaceutical supply and does not intend to adopt a policy in the CY 2024 OPPS final rule. However, CMS will consider the feedback received in future payment policy and is open to additional feedback from interested parties.
