TERMS AND CONDITIONS OF THE START-UP CORPORATE PARTNER PROGRAM

Participants in the Start-Up Corporate Partner Program shall be invoiced upon execution of this Application and Agreement and partner benefits shall commence at that time. The invoice shall be due upon receipt. Benefits including the individual memberships shall continue for one year and will automatically renew each year unless terminated by either party. A 30-day notice is required for termination of agreement. Individual memberships are assigned at the discretion of the Start-Up Corporate Partner and shall be effective for the term of this agreement. Companies are eligible to be Start-Up Corporate Partners for a maximum of two years, subject to other eligibility requirements. After two years, Start-Up Corporate Partner may join AABB as a Corporate Partner or Premium Corporate Partner.

AABB shall use all reasonable means to fulfill the benefits of the Start-Up Corporate Partner program. In the event that activities are canceled (e.g., in the instance of a virtual Annual Meeting), AABB reserves the right to cancel such events in its sole discretion. No pro rata refund of annual Start-Up Corporate Partner fees will be provided.
