**PURPOSE:** To oversee and administer the AABB Standards Program; to harmonize all AABB standard-setting activities.

- CHARGES:**
1. Prepare summary reports each year of all SPC activities using information provided by the Standards Committee Chairs with recommendations for action by the Board of Directors.
  2. Establish policies and procedures for AABB standard-setting activities. Include consideration of the timetable for production of new editions of the various standards publications.
  3. Activate the Standards Review Committee as required to review and approve recommendations from the various standards committees for variances to or exemptions from standards. The Review Committee will be composed of the Standards Program Committee chair, the chair of the committee, the applicable committee chair, and a public member as appropriate.
  4. Coordinate and ensure compliance with requests received from other committees, the Board and staff.
  5. Review, approve and/or comment on proposed and final standards (including revised, emergent, and interim standards) that are produced by the standards programs units.
  6. Review, approve and/or comment on guidance to standards, including Guidance Documents and Standards Source.
  7. In cooperation with the APC, periodically review the current strategies and proposed future directions of the Standards and Accreditation Programs to ensure coordinated processes.
