**CHAIR:** Pete Lux

**PURPOSE:** To ensure that the AABB Donor History Questionnaire(s) and Related Materials remain consistent with FDA requirements and recommendations and AABB Standards.

- CHARGES:**
1. Continue to work with FDA to identify and incorporate new FDA regulations and recommendations in the questionnaire(s) and all accompanying materials, as appropriate.
  2. Periodically obtain and review new research and feedback from users of current documents for the purpose of evaluating the materials (Donor History Questionnaire, User Brochure, Flowcharts, Medication List and Donor Educational Materials) for ease of use and increasing whenever possible the effectiveness of the materials. Evaluate opportunities for use of focus group and small surveys to engage members and update the DHTF.
  3. Identify solutions for challenges facing members to include: Spanish translation for US donor centers (not intended for global distribution), effective strategies to achieve compliance with new recommendations and minimize the burden of frequent version updates.
