



## Uniform Donor History–HPC Task Force

**CHAIR:** Nicole Draper, MD

**PURPOSE:** To create and maintain a standardized donor history questionnaires (HPC-DHQ) for hematopoietic progenitor cell (HPC) donors.

**CHARGES:**

1. Ensure the DHQs meet the FDA rules and guidance documents regarding the eligibility of HCT/P donors and other applicable requirements. Work with the FDA on incorporating new FDA guidance into the questionnaire as appropriate.
2. Ensure the DHQs meet requirements of voluntary standard setting organizations.
3. Periodically obtain and review feedback from users of current documents (HPC, Apheresis and HPC, Marrow Questionnaire and HPC, Cord Blood Questionnaire) for the purpose of evaluating and revising the materials (DHQ Questionnaire, User Instructions, Flowcharts, Medication List and Donor Educational Materials).
