AABB 75th GIVEAWAY TERMS AND CONDITIONS

This AABB 75th Giveaway (the “Giveaway”) is sponsored by the American Association of Blood Banks dba Association for the Advancement of Blood and Biotherapies (“AABB”). The Giveaway begins at 12:00am ET on March 11, 2022 and ends at 11:59pm ET on November 30, 2022 (the “Giveaway Period”).

1. How to Enter

NO PURCHASE NECESSARY TO ENTER OR WIN. To participate, eligible individuals must submit the trivia form (located on the AABB 75th Anniversary website at aabb.org/75th) providing their name and contact information, along with the correct answer to the current month’s trivia question.

Eight (8) trivia questions will be posted, one during each Giveaway Period month. The current question, as well as that question’s deadline, will be posted at aabb.org/75th. Answers to the trivia questions may be found on publicly accessible pages of the AABB website (aabb.org), and answers will be posted within two weeks of each month’s deadline.

All submissions must be received by AABB during the Giveaway Period. Individuals may enter the Giveaway once per question (for a maximum of eight times total). Anyone found to use multiple accounts to enter the Giveaway will be ineligible to win.

2. Eligibility

The Giveaway is open to legal residents of the U.S. and Canada who are 18 years or older. Individuals who are or were, within the past two years, employees of AABB or advertising/sales promotion agencies and the immediate families of each are not eligible. AABB is not responsible for lost, late, damaged, misdirected, or illegible entries or unsuccessful attempts to notify the Winners.

3. Winner Selection

A random drawing to select one (1) Winner per question – eight (8) Winners total -- will be held in Montgomery County, Maryland, on or about two (2) weeks after each question is posted, or finally on or about December 10, 2022 (“Determination Date”). The first entry drawn providing the correct answer at the close of each Giveaway Month will be declared a winner; and notified during the Giveaway Period. Participants need not be present to win.

Winners will receive a prize package of AABB 75th Anniversary items including memorabilia such as a t-shirt, mug, and badge pin. Winners will be contacted at the email address provided and asked to provide additional information including a preferred mailing address in the U.S. or Canada. **Prizes are non-transferable and not redeemable for cash.**
